In connection with the signing on 4 February 2016 of the Trans-Pacific Partnership Agreement (the “TPP Agreement”), I have the honour to confirm the following agreement reached between the Government of Chile and the Government of Australia during the course of negotiations of the TPP Agreement.

The Government of the Republic of Chile and the Government of Australia reaffirm that Article 3.12 “Treatment of Certain Spirits” of Section E “Non-Tariff Measures” of Chapter 3 “National Treatment and Market Access for Goods” of the Australia – Chile Free Trade Agreement (ACIFTA), signed at Canberra, Australia, the 30th day of July, 2008 shall continue to apply between the Parties.

I have the honour to propose that this letter and your letter of confirmation in reply, which shall be equally authentic in English and Spanish, shall constitute an agreement between Australia and Chile which shall enter into force on the first date on which the TPP Agreement is in force for both Australia and Chile.
